

Birmingham Secondary Schools Wellbeing Census

Pupil Information Sheet

Your school has agreed to begin yearly measurement of pupil's emotional well-being. Please take time to read this information and ask your teacher any questions you may have.

What is a wellbeing census and why is happening?

Wellbeing is about how well you are feeling; it can be things like how happy you are at the moment and how you get along with people around you. A census is a survey or a list of questions that is usually carried out to understand more about the people completing it. In this census we are looking at your wellbeing so we can better understand more about how young people are feeling in schools in Birmingham.

This information will help your school and others to improve how they go about improving the wellbeing of their pupils.

The survey is being carried out by Birmingham City Council and the University of Warwick.

How will the routine measurement be carried out?

Starting in May 2021 all pupils in your school will be asked to complete an online survey about your wellbeing. This is planned to happen once every year until you finish school. You will be asked to complete the measurement during the school day with a teacher present in the classroom. Your teacher can explain what you need to do to complete the survey. There are no wrong or right answers and you should simply answer the questions on how you are feeling. There are only 19 questions and it should not take you more than 10-15 minutes to complete.

Do you have to take part?

You do not have to take part if you would not like to. If you or your parent/guardian do not want to take part let your teacher know and they will remove you from the survey.

What will happen if I don't want to carry on being part of the study?

Taking part in this research is up to you and you can choose to withdraw from the survey without giving a reason, this will not affect you in any way. If you no longer want to take part then you can just tell your teacher who will then speak to the research team. You can withdraw at any time. Depending on when your record is deleted your anonymised information may already be written in reports. Once you have withdrawn any new information that has not already be published cannot be written in any new reports.

Is it confidential (private)?

All the answers you give will be kept private and pseudonymised (this means they will be coded so your name is not attached to your answers) before it is shared with Birmingham City Council or the University of Warwick. The school will share your Unique Pupil Number (this is the number you were given when you first started school) but it will not be used to identify you personally. It is used as it will allow your data to remain secure and linked to data collected over the following years. Your school will also share some of the basic information they already collect about you which will also be coded and not attached to your name.

What happens to the results of the survey?

All of the answers provided by every pupil will be looked at together by the research team and written up into reports that can then be shared further and published. This will be done without revealing any pupils who take part. In the future, all of the answers may be added to the National Pupil Database or used by other researchers. This can help to make wellbeing support in schools better in the future. In these cases, any research team wanting to use your private (pseudonymised) information will need to prove to a team of research safety experts that they will be using it safely (this is called ethical approval). In addition to ethical approval you, your parent/guardian or your school may need to agree to your pseudonymised information being used again.
